### PREREQUISITES

In order to understand the course, the student should have basic knowledge of human biology and physiology, elements of medical pathology and pharmacology and a preliminary knowledge of general psychology.

#### **LEARNING OBJECTIVES**

The integrated course of Psychiatry is aimed at providing the fundamentals of psychopathology and the history of psychiatry and a deep knowledge of pathophysiology, the clinic, the nosographic classification and the treatment of the main psychiatric disorders.

An overview of the organization of territorial psychiatric assistance will also be provided.

Moreover, the degree program trains graduates able to work in public and private institutions, companies and organizations, usually in multidisciplinary teams in science and psychological techniques areas. The educational objectives include the acquisition of systematic and up-to-date knowledge in different sectors of the psychological disciplines, as well as the biological (molecular, metabolic, physiological) and clinical (neurological, psychiatric, neurobiological) ones, that are the basis of knowledge on psychic processes, and of the anthropological, epistemological and ethical disciplines fundamental for the understanding of the cultural and deontological dimension of interventions for the promotion, maintenance and recovery of health and well-being conditions within public and private institutions for individuals at all stages life span. The training curriculum allows the acquisition of operational and applicative skills, including psychodiagnostic and psychological counseling for people suffering from physical and mental, cognitive and emotional disorders, but also of updated tools for communication and information management, experience and professional skills in the field of direct services to individuals, groups, organizations and communities in the specific area of competence and for the exchange of general information. Graduates will be able to settle within health facilities and psychological, medical and psychiatric services, third sector private agencies and public bodies, in the role of psychologist. Local authorities of Italy and many other Countries are carrying out initiatives which accentuate the



importance of health promotion by favoring integrated interventions and demonstrate how the training of clinical psychologist is a recognized requirement in the current cultural, scientific, social and institutional context.

# LEARNING OUTCOMES

## Knowledge and understanding

At the end of this course the student should be aware of:

- Acquisition of the main concepts of descriptive psychopathology
- Acquisition of knowledge about the historical evolution of psychiatry: models and schools of thought, definition and tasks of the psychiatrist
- Acquisition of systematic, operational and applicative skills of the main psychiatric disorders, their nosography and their clinic
- Acquisition of knowledge about psychopharmacological, psychotherapeutic and psychosocial interventions in psychiatric disorders
- Knowledge of the territorial organization of psychiatric services and care in psychiatry
- Acquisition of knowledge and skills in medical-legal and psychiatric-forensic field
- Acquisition of operational and application skills, including psychodiagnostic and psychological counseling, for people suffering from physical and mental, cognitive and emotional disorders.
- Acquisition of up-to-date skills and tools for communication, information management, professional experience regarding services for individuals, families, groups, organizations and communities.
- Interventions for the promotion, maintenance and recovery of health and well-being conditions within public and private institutions for individuals in all phases of life.
- Having acquired operational and application skills, including psycho-diagnostic and psychological counseling, for people suffering from physical and mental, cognitive and emotional disorders.
- Operate in institutions, companies and public and private organizations, in dependence or freelance, usually in multidisciplinary teams in the area of science and psychological techniques.

# Applying knowledge and understanding

At the end of the course, the student should have acquired:

- The ability to recognize and diagnose major psychiatric, mental, cognitive and emotional disorders.
- The ability to describe major psychiatric disorders from both a clinical and psychopathological perspective
- The ability to indicate appropriate treatment in both acute and chronic settings
- The ability to implement interventions for the promotion, maintenance and recovery of health and well-being conditions for people suffering from psychiatric, physical and mental, cognitive and emotional disorders.
- The ability to operate psychiatric and psychological consultations for individuals with physical and mental, cognitive and emotional disorders.
- The ability to communicate and manage information in the context of direct services to individuals, families, groups, organizations and communities.
- The ability to operate in institutions, companies and public and private organizations, in dependence or freelance, usually in multidisciplinary teams in the area of mental health.



• The ability to evaluate the quality, effectiveness and appropriateness of interventions. Be able to take responsibility for interventions, to exercise professional autonomy and to work collaboratively in multidisciplinary teams

## **Communication skills**

At the end of the course, the student must know:

- Use specific terminology appropriately.
- Use correctly the main terms of psychopathology in the appropriate context.
- Use the updated tools for communication and management of information, experience and professional skills in the field of services aimed at people, groups, organizations and communities.

#### **Making judgements**

At the end of the course, the student should know how to carry out general assessments of the topics covered.

#### Learning skills

The student will have acquired skills and learning methods suitable for the deepening and improvement of their skills in Psychiatry. At the end of the course, the student will have developed the ability to deepen the topics through the consultation of the scientific literature.

## **COURSE STRUCTURE**

Teaching is structured in lessons of frontal teaching, divided into lessons from 2 to 4 hours according to the academic calendar. Lectures will include theoretical lessons and possible seminars on the topics covered.

## **COURSE GRADE DETERMINATION**

Students' knowledge will be verified through a written exam with questions containing multiplechoice answers, related to the topics explored during classes and specific clinical cases.

The examination will be assessed according to the following criteria:

➤ Inadequate: major deficiencies and/or inaccuracies in knowledge and understanding of the topics; limited ability to analyze and synthesize, with frequent generalizations.

> 18-20: barely sufficient knowledge and understanding of the topics with possible imperfections; sufficient capacity for analysis, synthesis and autonomy of judgement.

 $\succ$  21-23: routine knowledge and understanding of the topics; correct analysis and synthesis skills with coherent logical argumentation.

> 24-26: fair knowledge and understanding of the arguments; good analytical and synthetic skills with rigorously expressed arguments.

> 27-29: comprehensive knowledge and understanding of the subject matter; considerable ability to analyze and synthesize. Good autonomy of judgement.
