This is a discipline that provides three ways of solving the non-fallible debtor crisis: the agreement, the consumer's plan and the liquidation procedure of the assets. By means of these procedures, a mechanism for extinction (controlled in court) of the obligations of the over-

	indebted subject is foreseen, which is not fallible, to be implemented through the collaboration
	of the Bodies for the settlement of the over-indebtedness crisis (hereinafter: Bodies), structures expressly provided for and regulated by law 3/2012 and the related implementing regulation. Professional associations can establish Bodies; in particular then the Chartered Accountants and Accounting Experts (as well as other professionals such as lawyers) can access, through the procedures provided by the implementing regulation, the qualification of Manager of the over-indebtedness crisis, lending their work within the Bodies in resolution proceedings.
