TUITION FEES AND CONTRIBUTIONS REGULATION FOR THE ACADEMIC YEAR 2020/2021 OF SAINT CAMILLUS INTERNATIONAL UNIVERSITY OF HEALTH SCIENCES (UNICAMILLUS)

Art. 1 - Introduction

This regulation was approved by the Organizational Technical Committee to regulate the payment of university fees and contributions for the academic year 2020-21. This Regulation applies to all students enrolled **for the first time** in the academic year 2020-21.

Art. 2 – Amount of contributions

a) EU and equiparated students¹

UniCamillus University adopts a variable contribution system according to the financial situation of the student's family. In particular, for EU and equiparated students, there are four brackets of contributions, determined on the basis of an indicator of income, assets and characteristics of the family unit (hereinafter ISEE).

Those who choose not to present the ISEE documentation will be automatically placed in the IV bracket.

The annual contributions are determined as in the tables below, according to the degree course of choice.

The amount of the contributions does not include accommodation, board, books or other services.

All amounts do not include the **regional tax which is determined annually by the Regione Lazio** and must be paid directly to LAZIODiSCO (please note that for the year 2019/2020 it amounted to $\in 140.00$).

The student must provide proof of the aforementioned payment by sending to UniCamillus a copy of it.

Upon payment of the first installment, the student must also pay the **fixed stamp** duty set by the Revenue Agency at € 16.00.

b) Non-EU students

For non-EU students not residing in one of the countries belonging to the European Union, the contributions are fixed, regardless of the value of the ISEE. The annual tuition fees are determined as in the tables below, according to the degree course of choice.

The amount of the contributions does not include accommodation, board, books or other services.

Non-EU students residing in Italy are treated as equiparated students pursuant to the article 26 of the law of 30 July 2002, n. 189 and subsequent. The citizens of Norway, Iceland, Liechtenstein, Switzerland and the Republic of San Marino are also treated as EU students.



All amounts do not include the **regional tax which is determined annually by the Regione Lazio** and must be paid directly to LAZIODiSCO (please note that for the year 2019/2020 it amounted to $\in 140.00$).

For the academic year 2019/2020 the amount was set at € 140.00. The student must provide proof of the aforementioned payment by sending to UniCamillus a copy of it.

Upon payment of the first installment, the student must also pay the **fixed stamp** duty set by the Revenue Agency at € 16.00.

Art. 3 - Deadlines, scholarships, penalties for late payment

The amounts due must be paid strictly within the deadlines indicated in this regulation.

Any late payment will result in the interruption of all student's educational and administrative activities including the possibility to take the exams and a penalty of \in 100 (for amounts lower than \in 1.000), of \in 200 (for amounts between \in 1.000 and 3.000) and of \in 300 for amounts higher than \in 3.000.

The interruption will end with the regularization of the contribution situation. The amounts must be paid by MAV, credit card, bank transfer or Paypal.

If the student fails to regularize his/her contribution situation within 20 days after the indicated deadlines, the University may consider the student's enrollment as forfeited.

In consideration of the provisions of article 3 of MD 927 of November 28, 2017 (UniCamillus University Establishment and Accreditation) "The State cannot be charged of financial burdens by the University establishment", the provisions contained in Article 9 of Legislative Decree 68 / 2012 are not applicable.

Students who are awarded a partial scholarship by UniCamillus are required to pay the first instalment upon enrollment and will be exempted from the total or partial payment of the other instalments of the annual tuition fees on the basis of the type of the scholarship they are awarded of.

Art. 4 – Determination of the tuition fees bracket

The tuition fees bracket is assigned to EU and equiparated students in Italy on the basis of the indicator of income, assets and characteristics of the family unit (hereinafter ISEE). To obtain the reduction on the payment of annual tuition fees, it is necessary to present the ISEE certification including the "Subsidies request form" page for the right to study at university.

For EU students not residing in Italy or with foreign incomes, whose family unit includes people not in possession of a tax code issued by the Revenue Agency, the family income is determined through the equalised ISEE indicator.

The student can request the inclusion in the reduced contribution brackets by presenting the ISEE certificate in accordance with the terms and provisions set forth. The ISEE certificate must be presented annually no later than November 30 of the year of the course in which the student is enrolled, even in the absence of changes in the income and/or assets. Missing the submission of the ISEE certificate, will automatically entail the inclusion in the highest contribution bracket.

The student must authorize the University to access the ISEE certificate, according to the methods and procedures described in the UniCamillus Portal - students section.



Art. 5 Outgoing transfer

The authorization to the outgoing transfer and the release of the related documentation can be granted only to the students in good standing, at the date of delivery of the application, with the payment of academic contributions, taxes, stamps etc. However, if the transfer request takes place starting from the first day of the month of the beginning of the lessons (as indicated in the calendar on the website), the payment of the entire of the contributions related to the annuity of registration will still be due.

In case of subsequent transfer or enrollment to another university, the student acknowledges and agrees that UniCamillus will be able to provide to the destination university all the useful information on the students' academic path for reconstructing their career.

The transfer request must be submitted following the procedure provided for.

Art. 6 Renouncement, waiver and forfeiture

The student who does not wish to continue the study course in which he/she is enrolled must submit to the University the "Study Waiver Request", using the format prepared by the University for the purpose of canceling the enrollment in UniCamillus from the National Student Registry Office and subsequent possibility of enrollment in another university. The student who presents a Study Waiver Request starting from the first day of the month of the beginning of the lessons indicated in the calendar on the website will still be required to pay the entire annuity of the contributions related to the year of enrollment. In the event of a waiver prior to the amount already paid, reference is made to the provisions of the Admission Calls to which the student participated.

The student who renounces his studies is in any case required to fully pay the contributions provided for in this regulation for the academic year in which he is enrolled. If the student fails to regularize his/her fees payment within 20 days after the related deadline, the University may consider his/her enrollment as forfeited, yet being due the full payment of the contributions provided for in this regulation for the academic year in which he/she is enrolled.

Students who do not intend to enroll in the years subsequent the first, must communicate their renunciation by August 31, prior to the academic year in which they do not intend to enroll.

Art. 7 Privacy

The data and information will be collected and processed in compliance with Legislative Decree 101/2018 and EU Regulation 679/2016.

Art. 8 Warnings



For the legal and interpretative purposes of this Regulation, the text approved by the Organizational Technical Committee on October 15th 2019, deposited at the Registrar's Office and written in Italian shall be authentic. For all matters not provided for in this document, reference is made to the Statute and the Regulations that regulate the functioning of the University's activities.
