Article 1 - Introduction

The uploading of up-to-date medical documentation on the UniCamillus WebApp platform, which is then verified by submitting the document in its original version, is one of the fundamental conditions to access university premises and to carry out the practical internship. All required medical documentation for access to university premises and for the curricular internship must be submitted in its original version during the medical examination, in order to enable the Competent Doctor to carry out the appropriate checks. All medical documentation uploaded on the UniCamillus WebApp and not verified by the UniCamillus Competent Doctor through the document in its original version will not be taken into consideration.

The list of required medical documentation, both for access to university premises and for the curricular internship, is subject to the UniCamillus Competent Doctor's evaluation, who is responsible for the University's health monitoring. Where requested by the UniCamillus Competent Doctor, the student commits to carrying out and producing the necessary clinical examinations.

N.B. For matters not covered by the present Regulation, please refer to the Academic Regulations of the single Degree Courses.

Article 2 - Access to UniCamillus premises and location

As provided for in the Calls for Admission to the Degree Courses or the Calls for Transfer to years following the first, the following medical documentation is required in order to access the University's premises:

- tuberculin test performed according to the Mantoux technique or by the Quantiferon test;
- certificate of vaccination against viral hepatitis B.

The tuberculin test is subject to annual expiry. The student therefore commits to renew the test taking into account its 12-month validity.

Failure to upload and/or renew the required tests will result in a suspension of academic activities.

Article 3 - Access to the curricular internship

The certificate of professional suitability for the internship is one of the mandatory requirements for admission to the internship course of the relevant Degree program.

This certificate, issued by the UniCamillus Qualified Medical Practitioner following a medical examination, is subject to expiry. Only those found eligible at the medical examination may be included in the list of students committed to the internship.

Should the medical evaluation not be carried out, or the medical certificate not be renewed, or should it be judged to be ineligible, the internship cannot be carried out.

The student commits to uploading the medical documentation requested by the Competent Doctor on the UniCamillus WebApp. Successful uploading of the documentation enables the student to receive the appointment for the medical examination. This appointment is always made through the UniCamillus WebApp platform.

When attending the medical examination, the student commits to presenting all the required medical documentation in its original form. Only students with the original medical documentation will be granted a medical examination.

During the medical examination, the Competent Doctor will assess the contents of the uploaded medical documentation and, on the basis of this assessment, will request any additions if deemed necessary.

A specific list of medical examinations to be produced is required, depending on the Degree Course to which the student belongs and the type of medical examination.

Article 4 - Medical documentation for the Internship

4.1 Three-Year Degree Course in Physiotherapy

For the Three-Year Degree Course in Physiotherapy, the following medical documentation is required depending on the type of medical examination.

First medical examination

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- HBV test: HBs-Ag; HbsAb;
- HCV test: Anti-HCV;
- Vaccination booklet: Hepatitis B, measles, rubella, mumps with two doses of MPR. Alternatively, titreanti-measles IgG; anti-rubella IgG; anti-mumps IgG;
- TBC test: Mantoux or Quantiferon Test.

Renewal medical examination

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- TBC test: Mantoux or Quantiferon Test.

4.2 Three-Year Degree Course in Nursing

First medical examination

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- TSH test and Reticulocytes test;
- HBV test: HBs-Ag; HbsAb;
- HCV test: Anti-HCV;



- Vaccination booklet: Hepatitis B, measles, rubella, mumps with two doses of MPR. Alternatively, titreanti-measles IgG; anti-rubella IgG; anti-mumps IgG;
- TBC test: Mantoux or Quantiferon Test.

Renewal medical examination

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- TSH test and Reticulocytes test;
- TBC test: Mantoux or Quantiferon Test.

4.6 Single Cycle Degree Course in Medicine and Surgery

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- HBV test: HBs-Ag; HbsAb;
- HCV test: Anti-HCV;
- Vaccination booklet: Hepatitis B, measles, rubella, mumps with two doses of MPR. Alternatively, titreanti-measles IgG; anti-rubella IgG; anti-mumps IgG;
- TBC test: Mantoux or Quantiferon Test.

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- HBV test: HBs-Ag; HbsAb;
- HCV test: Anti-HCV;
- Vaccination booklet: Hepatitis B, measles, rubella, mumps with two doses of MPR. Alternatively, titreanti-measles IgG; anti-rubella IgG; anti-mumps IgG;
- TBC test: Mantoux or Quantiferon Test.

Renewal medical examination

- Routine blood tests: blood glucose, azotemia, transaminases, Gamma-GT, complete blood count;
- TBC test: Mantoux or Quantiferon Test.

Article 5 - Medical documentation and protection of personal data

In compliance with the provisions on the protection of personal data set out in Regulation (EU) 2016/679, medical documents are handled in full compliance with the principles of lawfulness, correctness and transparency, as well as relevance and non excessiveness with respect to their purpose (Article 5 of the GDPR).

The treatment of the particular categories of personal data (relating to the health status) of students is referred to the exclusive competence of the University Qualified Medical Practitioner, in the capacity of Autonomous Owner, as well as of his collaborators, all duly designated persons, authorized to the treatment pursuant to and for the purposes of Article 29 of Regulation (EU) 2016/679 and Article 2-quaterdecies of Legislative Decree 2003/196 as amended by Legislative Decree 2018/101.

Article 6 - Warnings

For the legal and interpretative purposes of this Regulation, only the text approved by the Organizing Committee on 17th February 2022, as amended following the resolution of 15th June 2022, is deemed authentic, the original of which is filed at the offices of the Registrar's Office and drafted in Italian. A certified copy may be requested.
