# AMENDMENTS OF THE CALL FOR APPLICATION FOR THE ADMISSION OF EU AND EQUIPARATED STUDENTS TO THE THREE-YEAR DEGREE COURSES IN HEALTH PROFESSIONS IN ITALIAN OF THE SAINT CAMILLUS INTERNATIONAL UNIVERSITY OF HEALTH SCIENCES (UNICAMILLUS) FOR THE ACADEMIC YEAR 2021/2022

# THE RECTOR

**Given** the Statute of the Saint Camillus International University of Health Sciences (UniCamillus);

**Given** the Didactic Regulations of Saint Camillus International University of Health Sciences (UniCamillus);

**Given** the Rector's Decree no. 110 of 5<sup>th</sup> November 2020 "Call for application for the admission of EU and equiparated students to the three-year Degree Courses in Health Professions in Italian of the Saint Camillus International University of Health Sciences (UniCamillus) for the Academic Year 2021/2022" and in particular the third clause of Article 13 "The University reserves the right to change dates, times, testing location and publication dates of results, internship locations, both in the Region and out of the Region, and teaching methods, if it is deemed necessary for organizational reasons and/or for reasons of health safety";

**Given** the Prime Ministerial Decree (DPCM) of 14<sup>th</sup> January 2021 "Further implementing provisions of the decree-law of 25<sup>th</sup> March 2020, no. 19, converted, with amendments, by law 22<sup>nd</sup> May 2020, no. 35, bearing «Urgent measures to deal with the epidemiological emergency from COVID-19", of the decree-law of 16<sup>th</sup> May 2020, no. 33, converted, with amendments, by law 14<sup>th</sup> July 2020, no. 74, containing "Additional urgent measures to deal with the epidemiological emergency from COVID-19", and the decree-law of 14<sup>th</sup> January 2021 no. 2, containing "Further urgent provisions on the containment and prevention of the epidemiological emergency from COVID-19 and the holding of elections for the year 2021" and in particular art. 1, paragraph 10, lett. z);



# **DECREES**

## Article 1

The admission test will be carried out in home-based mode, i.e. remotely at the home or other place chosen by the candidate.

For candidates who have already completed the registration before the latest provisions, registration is also considered valid for the new test delivery mode.

# Article 2

The following amendments are applied to the Rector's Decree no. 110 of 5<sup>th</sup> November 2020:

a) In Article 2 – Application submission , the date  $26^{th}$  January 2021 is substituted with the date  $14^{th}$  February 2021.

The new Article 2, therefore, states:

#### Article 2 - Application submission

Registration for the admission test will be possible:

- starting from 9th November 2020 until 14th February 2021 for the ordinary session;
- until 29<sup>th</sup> September 2021 at 1 PM for the extraordinary session (if any).

In order to complete the registration for the admission test, each candidate needs to connect to the web portal <a href="https://unicamillus-admission.ilmiotest.it">https://unicamillus-admission.ilmiotest.it</a>, register and follow the instructions.

At this stage, the candidates will be asked to select the Degree Course which they intend to apply for. In addition to the one selected as his/her first choice, the candidate can also indicate in order of preference one or more alternative Courses – even all of them – he intends to apply for, in case he/she is not able to be part of the list of candidates admitted for the Degree course indicated as his/her first choice.

The candidate is responsible for the information given when filling in the registration form. The presence of false, incorrect or omitted information even in only one section leads to the immediate exclusion from the test or, if already passed, the cancellation from the lists of those admitted.



Upon submission of the form for the registration to the test the candidate authorises UniCamillus to carry out checks at institutions and authorities that have issued or validated the academic qualifications attached to the application.

In case of difficulty in the registration procedure, candidates can send an e-mail to admission@unicamillus.org for assistance.

For all candidates, the participation fee of  $\in$  110.00 (one hundred and ten) is not refundable for any reason (also in the event the student fails to be present at the admission test).

The payment of the fee for access to the admission test does not complete the registration procedure. The registration process must be completed in its entirety under penalty of exclusion.

b) In Article 5 – UniCamillus testing procedure, the date 30<sup>th</sup> January 2021 is substituted with the date 20<sup>th</sup> February 2021. Moreover, in par. 6 after the word "devices" the sentence "- *if not necessary for carrying out the "computer based from home" test and according to the instructions that will be given by the test administration-* " is added.

The new Article 5, therefore, states:

#### Article 5 - UniCamillus testing procedure

The written test will take place in Rome on  $20^{th}$  February 2021 for the ordinary session and on  $2^{nd}$  October 2021 for the extraordinary session (if any) at the location and time that will be specified in the convocations to the test.

The University reserves the right to plan additional sessions, change dates, times, locations of the admission test, publication dates of results and the test delivery method, also electronically, if it is deemed necessary for organizational reasons and/or for reasons of health safety.

In case of deferment, as long as it is decided prior to the deadline for the application to the admission test, it will be possible to postpone the deadlines for the submission of the applications and, where deemed useful, accordingly modify the other dates provided for by this Call.

On the day of the test candidates must submit a valid Identification Document (ID) pursuant to art. 35 of the D.P.R. December 28th 2000 no. 445.

During the tests it is absolutely forbidden the use of mobile phones, calculators, tablets, web-connecting devices and the consultation of printed books and / or manuscripts and notes. The possession of these devices must be reported to the operators who, if deemed necessary, might keep the device and then return it at the end of the test.



The use of pens or other unauthorized writing instruments is also forbidden.

Non-compliance with these provisions will result in the exclusion from the test or from its continuation if already begun.

c) In Article 6 – Final ranking for admission, the date 4<sup>th</sup> February 2021 is substituted with the date 23<sup>rd</sup> February 2021.

The new Article 6, therefore, states:

# Article 6 - Final ranking for admission

Following the completion of the test, a single ranking list based on the score achieved by each candidate in the admission test will be drawn up.

UniCamillus will publish the final ranking on the website www.unicamillus.org, guaranteeing the anonymity of the candidates, according to the following deadlines:

- within 23<sup>rd</sup> February 2021 for the ordinary session;
- within 7<sup>th</sup> October 2021 for the extraordinary session (if any).

Each candidate can verify his position in the ranking using the unique code assigned to them when registering for the admission test.

In case of a tie, the score obtained by the candidate in the solution, respectively, of the questions pertaining to the sections of logical reasoning, general knowledge and scientific knowledge prevails in descending order. In case of further parity, the youngest candidate will prevail. In the event of a further tie, the youngest candidate will prevail.

d) In Article 8 – Pre-enrolment and scrolling procedure (only for the ordinary session), the date  $5^{th}$  January 2021 is substituted with the date  $24^{th}$  February 2021 and the date  $12^{th}$  February 2021 is substituted with the date  $2^{nd}$  March 2021.

The new Article 8, therefore, states:

# Article 8 - Pre-enrolment and scrolling procedure (only for the ordinary session)

Starting from  $24^{th}$  February 2021 and until  $2^{nd}$  March 2021 candidates who have ranked in a favourable position for the pre-enrolment must carry out the pre-enrolment procedure on <u>www.unicamillus.org/ammissioni</u> as follows:



- Candidates who ranked favourably can pre-enrol;
- By 2<sup>nd</sup> March 2021 those admitted must, under penalty of exclusion from the ranking, pay the first instalment of the tuition fees of Euro 1.500,00;

Any slot not covered will be managed according to the following scrolling procedure:

- publication on the website <u>www.unicamillus.org/ammissioni</u> of the number of available slots due to missing enrolments or withdrawals (reopening of the ranking);
- candidates admitted through the scrolling procedure will have to pay the first instalment by 6 PM of the second day following the reopening of the ranking;
- the scrolling procedure will be reiterated until all available slots are filled.

Candidates not complying with the deadlines indicated above will be considered renouncing candidates and will lose the right to enrol.

## Article 3

With the exception of the amendments communicated in this document, what is indicated in the Competition Notice published with Rector's Decree no. 110 of 5<sup>th</sup> November 2020 remains valid.
