Academic Year 2019/2020 n. 92 of October 8th 2019

Change of the art.1 –Available slots and admission requirements of the Call for application for the admission of EU and NON-EU students to the degree courses of Health Professions in English of Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2019/2020 (Rector's Decree 83 of October 24th 2019)

THE RECTOR

Given the Rector's Decree of October 24th 2019 "Call for application for the admission of EU

and non-EU students to the Health Professions Degree Courses in English of the Saint Camillus International University of Health Sciences (UniCamillus) for the academic

year 2019/2020"

Given the M.D. of July 8th 2019, prot. n. 616 on "Definition of available slots for the Health

Professions three-year Degree Courses - academic year 2019/2020"

Given the M.D. 597 of June 28th 2019 "Definition of the number of slots allocated to the

non-EU candidates residing abroad for all three-year and six-year Degree Courses

with admission test at national level – academic year 2019/2020"

Considering that, following the procedure of enrolment in the first year of the Degree Courses in

the Health Professions of UniCamillus University in Rome, academic year 2019/2020, as from the Rector's Decree n. 80 of October 23rd 2019 "Acknowledgement of the ranking of the candidates taking part in the Call for application for the admission of EU and equiparated students to the Degree Courses in Health Professions of UniCamillus University for the academic year 2019/2020", and to the Rector's Decree n. 81 of October 23rd, 2019 "Acknowledgement of the ranking of the candidates taking part in the Call for Application for the admission of non-EU students to the Degree Courses in Health Professions of UniCamillus University for the academic year 2019/2020" and considering the occuring requests for transfer, the following slots

have become available:

DECREES

Article 1

The change, as follows, of the table of the **available slots** set out in art. 1 of the "Call for application for the admission of EU and non-EU students to the Health Professions Degree Courses in English of the Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2019/2020", in the section regarding the available slots for the Degree course in Physiotherapy which are increased from 1 to 3.

Article 2

Apart from the change as provided for in the art. 1 (increase of the vacancies of the Degree course in Physiotherapy from 1 to 3) the Rector's Degree 83 of October 24th 2019 "Call for application for the admission of EU and non-EU students to the Health Professions Degree Courses in English of the Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2019/2020" remains unchanged.

This decree will be stored in the relevant register of the UniCamillus University.

¹⁾ EU and equiparated candidates can take part in the selection for the admission to the three-year degree course in Physiotherapy even though at the moment there are no slots allocated for them. This is possible because the M.D. n° 597 of June 28th 2019 (definition of the slots allocated for non-EU candidates residing abroad) provides that any slot not covered by non-EU candidates residing abroad is made available for EU and non-EU students residing in Italy in time for the reordering of the rankings. Basically, EU and equiparated candidates who will take part in the selection for the admission to the three-year Degree Course in Physiotherapy, will take over, according to the ranking, the slots originally allocated for non-EU students, once the University will have assessed that some of the slots allocated for the non-EU candidates have remained available.
