AMENDMENT OF RECTOR'S DECREE No. 228 OF 3 DECEMBER 2021 "CALL FOR APPLICATION FOR THE ADMISSION OF EU AND EQUIPARATED STUDENTS TO THE 6-YEAR DEGREE COURSE IN DENTISTRY AND DENTAL PROSTHETICS OF SAINT CAMILLUS INTERNATIONAL UNIVERSITY OF HEALTH SCIENCES (UNICAMILLUS) FOR THE ACADEMIC YEAR 2022/2023"

THE RECTOR

- Given the Statute of the Saint Camillus International University of Health Sciences (UniCamillus);
- **Given** the Didactic Regulations of Saint Camillus International University of Health Sciences (UniCamillus);
- **Given** the Law no. 168 of May 19th 1989 on the foundation of the Ministry of the University and Scientific Research;
- **Given** the Law no. 264 of August 2nd 1999, containing "Regulations on access to University courses" and subsequent amendments and integrations;
- **Given** the Law no. 189 of July 30th 2002 "Amendments on legislation on immigration and asylum" and subsequent amendments and integrations, and notably art. 26;
- **Given** the Decree no. 270 of October 22nd 2004 "Amendments to the regulation containing dispositions on the didactic autonomy of the Universities", approved with Decree of the Minister of University and Scientific and Technologic Research of November 3rd 1999, no. 509;



- **Given** the Ministerial Decree of March 16th 2007, which has established the classification of the Degree Courses;
- **Given** The Tuition Fees and Contributions Regulations for the academic year 2022/2023 approved by the Organising Technical Committee of UniCamillus on November 9th 2021;
- **Given** The Resolution of the Organising Technical Committee of November 9th 2021, approving the Call for Application for the admission of EU and equiparated students to the six-year Degree Course in Dentistry and Dental Prosthetics of Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2022/2023.
- **Given** the Rector's Decree no. 228 of 3 December 2021, which issued the Call for Application for the admission of EU and equiparated students to the six-year Degree Course in Dentistry and Dental Prosthetics at the Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2022/2023.
- **Considering** the worsening of the current pandemic situation due to the spread of the Omicron variant of Covid19 which, together with the previous variants of the virus, today recorded an exponential increase, and whose peak is commonly expected just near the originally planned date of the test;
- **Taking into account** the fact that many candidates may be unable to physically participate in the admission test because, for example, they are forced into isolation because they are positive for Covid19, in quarantine or for other reasons related to the same problem;
- **Given** the note prot. U.000205 of 5 January 2022 sent by the Ministry of University and Research to the Rectors of Italian Universities which, in the light of the evolution of the epidemiological framework, still allows Universities to use forms of remote control of their face-to-face activities.

DECREES

Article 1

The admission test will be carried out in home-based mode, i.e. remotely at the home or other place chosen by the candidate.

For candidates who have already completed the registration before this Decree, registration is also considered valid for the new test delivery mode.



Article 2

The following amendments are applied to the Rector's Decree no. 228 of 3rd December 2021:

- a) In Article 2 Application submission , the date 26^{th} January 2022 is substituted with the date 9^{th} February 2022.
- b) In Article 3 Support for candidates with disabilities or specific disorders, the date 16th January 2022 is substituted with the date 26th January 2022.
- c) Article 5 UniCamillus testing procedure, is replaced as follows:

For the ordinary session, the written test will be held in home-based telematic mode with remote surveillance and assistance on 12 February 2022 (the University reserves the right, for organizational reasons, to also add the date of 13 February 2022). For the extraordinary session (if any), the written test will be held physically in Rome on 1 October 2022, at the venue and at the time that will be indicated in the invitation to the test.

The University reserves the right to plan additional sessions, change dates, times, locations of the admission test, publication dates of results and the test delivery method, also electronically, if it is deemed necessary for organizational reasons and/or for reasons of health safety, notifying all candidates through public notices on the University website.

In case of deferment, as long as it is decided prior to the deadline for the application to the admission test, the University reserves the right to postpone the deadlines for the submission of the applications and, where deemed useful, accordingly modify the other dates provided for by this Call.

On the day of the written test candidates must show a valid identification document according to art. 35 of the D.P.R. 28th December 2000 no. 445.

During the test the use of mobile phones, calculators, tablets and web-connecting devices is absolutely forbidden - except for carrying out the "computer based from home" test and according to the instructions that will be given by the administration of the test. The consultation of printed books and / or manuscripts and notes is equally forbidden.

During the test it will be allowed to use a blank sheet and a pen for any notes and / or calculations. Non-compliance with these provisions will result in the exclusion from the test or from its continuation if already begun.

- d) In Article 6 Final ranking for admission, the date 2^{nd} February 2022 is substituted with the date 16^{th} February 2022.
- e) In Article 7 Pre-enrolment Phase no. 1 (only for the ordinary session):
- in par. 1 the date 3^{rd} February 2022 is substituted with the date 10^{th} February 2022 and the date 17^{th} February 2022 is substituted with the date 25^{th} February 2022.
- in par. 1 letter c) the date 10th February 2022 is substituted with the date 25th February 2022.

Article 3



In light of the amendments indicated in the previous article 2, is decreed the approval and issuance of the Call for Application attached to this Decree, of which the Student Contract constitutes integral and substantial part, relating to the admission of EU and equiparated students to the six-year Degree Course in Dentistry and Dental Prosthetics of the Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2022/2023.

CALL FOR APPLICATION FOR THE ADMISSION OF EU AND EQUIPARATED STUDENTS TO THE 6-YEAR DEGREE COURSE IN DENTISTRY AND DENTAL PROSTHETICS OF THE SAINT CAMILLUS INTERNATIONAL UNIVERSITY OF HEALTH SCIENCES (UNICAMILLUS) FOR THE ACADEMIC YEAR 2022/2023

Article 1 – Available slots and admission requirements

Saint Camillus International University of Health Sciences, hereunder referred to as "UniCamillus" or the "Univesity", has published for the academic year 2022/2023 the public call for applications for the admission to the first year of the Degree Course in Dentistry and Dental Prosthetics.

25 (twenty-five) slots are available for the EU candidates and for the categories as of art. 26 of the law no. 189 of July 30th 2002 and subsequent amendments and alterations for the Degree Course in Dentistry and Dental Prosthetics.

The number of slots available may vary as a result of what will be established by Decree of the Ministry of University and Research (MUR), in accordance with Law no. 264 of August 2nd 1999. The Decree of the MUR may decide the confirmation, increase or decrease of the slots specified in this announcement. The University will make the aforementioned Ministerial Decree accessible on its website.

The selection procedures include two test sessions: ordinary and extraordinary (if any). If, following the outcome of the registration procedures of the ordinary session, there are vacancies, an extraordinary session will be held. The number of vacancies and any extraordinary session will be notified by publication on the University website, which is the only official communication tool of the University.

Citizens from Norway, Iceland, Liechtenstein, Helvetic Confederation, Republic of San Marino and Vatican City are treated as EU candidates.

Candidates in possession of a secondary school diploma on the date of the test and candidates who, on the date of the test, are attending the last year of secondary school are admitted to participate in the admission test.

For candidates who have already achieved a secondary school diploma issued by a foreign education system or are enrolled in the last year necessary to obtain it, foreign qualifications are deemed valid, if obtained after at least 12 years of schooling; these qualifications must be accompanied by the Declaration of Value issued by the Italian diplomatic authorities.

In case the local education system provides for 11 or 10 years of schooling, the qualification is valid if it is integrated with one or two years of University studies, provided that all the exams scheduled for those academic years have been passed.

Candidates who do not possess or do not submit adequate qualifications within the deadlines indicated below, according to current legislation, will lose the benefit to enrol or will lose their enrolled status - if already admitted - and have no right to the refund of the amount paid to the University.



With reference to the recognition of foreign qualifications, the University will take into account the indications provided by the Ministry of University and Research "Procedures for entry, stay and enrolment of foreign / international students to courses of higher education in Italy for the academic year 2021/2022" and subsequent amendments (http://www.studiare-in-italia.it/studentistranieri).

To those eligible ranking favourably the University will make available **two cycles** of ancillary seminars for the medical profession (herein after referred to as the "**Seminars**"). The Seminars are to be used in exclusive way and, although not part of the academic curriculum or subject to examination, they are considered by the University to be extremely useful for educational purposes. The use of the Seminars will be made available by the University through the activation and transmission in favor of the single candidate usefully classified, of unique credentials that cannot be transferred or made available to others and that can be used with maximum flexibility according to the user preferences. With the activation and transmission of the credentials, the student has full availability of the contents of the Seminars that, for this reason, will be considered used. Failure to attend the Seminars constitutes an independent choice by the student and cannot therefore, under any circumstances, be invoked for requests for the refund of contributions already paid, which will therefore not be reimbursed by the University to the student even following the presentation of study waiver or transfer requests, referred to in Article 13.

Article 2 - Application submission

Registration for the admission test will be possible:

- starting from 3rd December 2021 until 9th February 2022 at 1 PM for the ordinary session;
- until 28th September 2022 at 1 PM for the extraordinary session (if any).

In order to complete the registration for the admission test, each candidate needs to connect to the web portal https://unicamillus-admission.ilmiotest.it/, register and follow the instructions.

The candidate is responsible for the information given when filling in the registration form in all its parts. The presence of false, incorrect or omitted information even in only one section leads to the immediate exclusion from the test or, if already passed, the cancellation of the candidate from the lists of those admitted, without any right to reimbursement of payments made.

Candidates wishing to register for the admission test before reaching the age of majority must follow the procedure with the help of a person who exercises parental authority.

Upon submission of the form for the registration to the test the candidate authorises UniCamillus to carry out checks at institutions and authorities that have issued or validated the academic qualifications attached to the application.

In case of difficulty in the registration procedure, candidates can send an e-mail to admission@unicamillus.org for assistance.



For all candidates, the participation fee of € 170.00 (one hundred and seventy) is not refundable for any reason (also in the event the student fails to be present at the admission test). The payment of the test participation fee, which must in any case be made in compliance with the deadlines indicated above, can be made through Paypal in the manner provided for in the online system.

The payment of the fee for access to the admission test does not complete the registration procedure for the admission test. The registration process itself must be completed in its entirety under penalty of exclusion.

Article 3 – Support for candidates with disabilities or specific disorders

Candidates with disabilities or with specific learning disabilities (SLD), in relation to the specific difficulties attested by medical certification, can make explicit request for aids and/or additional time compared to those established for the other candidates, as well as further measures to guarantee equal opportunities in carrying out the entry test. "Candidates with disabilities" shall mean: blind candidates, suffering from absolute blindness or with a visual residual not exceeding one tenth in both eyes; deaf candidates, suffering from deafness from birth or before learning the spoken language; candidates with a civil disability percentage equal to or greater than 66%; candidates in possession of the disability certification as from Italian Law 104/92 as amended by Italian Law 17/99. These conditions must result from an appropriate medical certification issued by a competent public health authority. The certifications will be accepted only if issued in Italian or English language.

"Candidates with SLD" shall mean: candidates with a diagnosis of dyslexia, dysgraphia, dyscalculia, dysorthography, resulting from appropriate clinical certification, issued by no more than three years by the National Health Service, or by specialists or structures accredited by the regional health service. The additional time allocated to candidates with SLD will be 30% more than the time set for admission tests, in accordance with Italian Ministerial Decree 5669/2011.

This request and the related medical documentation must be sent via registered mail with return receipt or hand delivered to the Registrar's Office – UniCamillus University – Via di Sant'Alessandro – 00131 Roma, to be received no later than 26th January 2022 at 1 PM for the ordinary session and 13th September 2022 at 1 PM for the extraordinary session, if any.

Article 4 – Examination topics and admission criteria

4.1 The admission test will be in English and consist of a multiple choice written test, with five response options, among which the candidate must identify only one, discarding the wrong, arbitrary or less likely conclusions. In particular, the test is composed of 60 questions in English, based on the programs indicated in Annex A and thus divided:

- 15 questions on logical reasoning and reading comprehension;
- 35 questions on scientific topics (10 on Biology, 10 on Chemistry, 10 on Physics and 5 on Maths);



• 10 questions on humanitarian topics in various ways related to the specific mission of UniCamillus, better described on the University website.

The admission test will last 60 minutes.

For the evaluation of the test a maximum score of 90 (ninety) points is attributed according to the following criteria:

- 1,5 points for each correct answer;
- minus 0,25 points for each wrong answer;
- 0 points for each answer not given or multiple marking, or for all ambiguous responses.

4.2 Questions aimed at obtaining the scholarship

At the end of the exam, whether it coincides with the 60-minute expiration, or earlier in the event of voluntary closure of the test, each candidate will have to develop 3 (three) additional open tracks with brief arguments on issues concerning the humanitarian potential of the dentist profession in favor of less fortunate populations or groups. To complete these 3 additional tracks the candidate will have an amount of time proportional to the overall time of the admission test defined by this call. These tracks will not contribute to the evaluation of the test for the purposes of the ranking for admission to the Degree Course, but will be subject to independent evaluation for the purpose of recognition of the scholarship worth 5,000 Euros which will be paid upon payment of the last installment scheduled for 31 January 2023. In case of study waiver or transfer before 31 January 2023, the winning candidates will not benefit from this scholarship.

Article 5 – UniCamillus testing procedure

For the ordinary session, the written test will be held in home-based telematic mode with remote surveillance and assistance on 12 February 2022 (the University reserves the right, for organizational reasons, to also add the date of 13 February 2022). For the extraordinary session (if any), the written test will be held physically in Rome on 1 October 2022, at the venue and at the time that will be indicated in the invitation to the test.

The University reserves the right to plan additional sessions, change dates, times, locations of the admission test, publication dates of results and the test delivery method, also electronically, if it is deemed necessary for organizational reasons and/or for reasons of health safety, notifying all candidates through public notices on the University website.

In case of deferment, as long as it is decided prior to the deadline for the application to the admission test, the University reserves the right to postpone the deadlines for the submission of the applications and, where deemed useful, accordingly modify the other dates provided for by this Call.

Article 6 - Final ranking for admission

The results of the test will be available on:

- 16th February 2022 for the ordinary session;
- 5th October 2022 for the extraordinary session (if any).

Each candidate is invited to keep the unique code assigned to him when registering for the admission test.

Candidates who scored less than 20 points will not be admitted, regardless of their position in the ranking.

The winning candidates are those scoring more than 20 points and ranking favourably with reference to the number of available slots as from Art.1 of this Call.

In the event of a tie in the score, the candidate who obtained the highest score in the solution of humanitarian questions prevails. In the event of a further equal score, the youngest candidate will prevail.

Candidates not admitted in the ordinary session can re-apply for the extraordinary one (if any) by re-submitting the application for admission to the test in accordance with the procedures and timing set out in art. 2 of this Call.

Article 7 – Pre-enrolment Phase no. 1 (only for the ordinary session)

Starting from 17th February 2022 and until 25th February 2022 at 1 PM, candidates who have obtained a useful position in the ranking are required to carry out the procedure following the instructions published on the website www.unicamillus.org/ammissioni in the following ways:

- a) candidates ranking from position 1 to position 75 will be able to pre-enrol;
- b) candidates from position 76 to position 95 of the ranking will be able to pre-enrol with reserve. This pre-enrolment will be confirmed on the basis of the placement in the ranking, if slots remain available due to the non-enrolment of some of the candidates classified from position 1 to position 75:
- c) by the date of 25th February 2022 at 1 PM, those admitted (from position 1 to position 75) and those admitted with reserve (from position 76 to position 95) are required, under penalty of exclusion from the ranking:
 - 1. to pay the first fee of Euro 7,000.00 (seven thousand/00) for the administrative



and secretarial costs for the pre-enrolment and for the availability of the first online cycle of Seminars;

2. to submit a declaration in which they certify that they have fully read the Student Contract (attached to this announcement) and the Tax and Contribution Regulations for the academic year 2022/2023 (available on the University web portal at the following link https://www.unicamillus.org/it/regolamenti/).

At the time of the pre-enrolment procedure, the minor candidate must have the procedure carried out by the person exercising parental authority, who must sign all the documents and attach a valid identity document.

Any slots not covered both in the list of pre-enrolment and pre-enrolment with reserve will be managed according to the following scrolling procedure:

- publication on the website <u>www.unicamillus.org/ammissioni</u> of the number of slots available due to non-enrolment or study waiver (reopening of the ranking);
- those admitted for "scrolling" of the ranking must proceed with the payment of the administrative and secretarial fees as indicated in above mentioned letter c) by 5 PM on the second working day following the reopening of the ranking;
- the "scrolling" procedure will be repeated until the available slots indicated in this article are filled. It is understood that candidates who have obtained a score lower than 20 points will not be admitted, regardless of their position in the ranking.

The publication of the ranking and all related notices on the University website has the value of official communication to interested parties. Any personal communications that may be sent to the email addresses entered into the system by candidates during the registration phase for the test, will have the sole purpose of facilitating in following the competition process, but this will in no way replace the notices published on the University website, which represents the only official communication tool of the University. It therefore remains the responsibility of the candidate to verify his / her position by taking action in the manner and within the terms provided for the preenrolment.

Candidates not complying with the deadlines indicated above will be considered renouncing candidates and will lose the right to pre-enrol.

Pre-enrolment is considered subject to conditions (sub conditione) until the publication of the Ministerial Decree for the allocation of available slots at UniCamillus for the a.y. 2022/2023.

Without prejudice to what provided for by the following paragraph, the amount of the first instalment can only be refunded to candidates enrolled under conditions (sub conditione) for whom it is not possible to confirm enrolment due to the exhaustion of the available slots by candidates with a better ranking. The reimbursement will take place by the beginning of the Academic Year 2022/2023. Only and exclusively in this case, the costs related to the provision of the Seminars will be covered by the University.



In case the pre-enrolment is completed in remote modality or not at the University's premises, the student, within 14 (fourteen) days from the date of pre-enrolment (the count of the date starts from the date in which payments were made), can exercise the right of waiver, expressly informing UniCamillus regarding his intention to reconsider the pre-enrolment, through certified letter with return receipt. If the right of reconsideration is exercised, UniCamillus will reimburse the student for the amounts paid for the pre-enrolment within the following 14 (fourteen) days, withholding only the 5% of the amount paid by the student, for secretarial and pre-enrolment services born by the University, - using the same means of payment used by the User for the initial payment, unless expressly indicated a different means of payment.

Apart from the mandatory cases expressly provided for in this announcement, no reimbursement of payments made will be made under any circumstances.

Article 8 - Enrolment Phase no. 2 ordinary session

From 6th July 2022 and until 14th July 2022 at 1 PM, candidates admitted to enroll in the first year of the course must complete their enrolment procedure online and submit the following documentation:

- a) Enrolment application (available online) addressed to the Rector, and acceptance of the UniCamillus Code of Ethics;
- b) Contract with the Student signed for acceptance (by the candidate or, if a minor, by a person who legally exercises parental authority),;
- c) Digital photograph (to be uploaded);
- d) Photocopy of a valid identity document and photocopy of the fiscal code (foreigners legally residing in Italy must submit a valid residence permit);
- e) Certification or authenticated copy of the High School Diploma or, provisionally, self-certification, pursuant to Presidential Decree 445/2000 regarding the possession of a high school diploma;
- f) Proof of payment of the second instalment of the administrative and secretarial costs for the enrolment and for the availability of the second online cycle of Seminars for an amount of Euro 7.000,00 (seven thousand/00). The third and last payment for the enrolment in the first year for tuition, testing sessions and all other activities related to the academic year, equal to Euro 7.000,00 (seven thousand/00), must be paid by 31st January 2023;
- g) Undersigned Privacy policy (available online);
- h) Revenue stamp of Euro 16,00;
- i) (Potential) study waiver documents (if enrolled in other university);
- j) Proof of payment of the Regional Tax (to be paid directly to the Regione Lazio).

At the time of enrolment, the minor candidate must have all the documents signed by the person exercising parental authority, who must also attach a valid identity document.

For any interlocution relating to the student's career, including administrative matters, starting from the age of majority, the University will deal exclusively with the the student, therefore



communications, of any nature and purpose, from third parties, including parents, will not be taken into consideration and in any way met.

If, following the publication of the Ministerial Decree assigning slots to UniCamillus for the a.y. 2022/2023, further slots become available with respect to those already stated in this Call, the candidates found to be suitable are required to proceed with the enrolment according to the procedures and deadlines provided for in this article, except for what is indicated in letter f) as the candidate is required to present a receipt certifying the payment of the amount of Euro 14,000.00 (fourteen thousand/00) equal to the sum of the expenses referred to in letter c) of Art. 7 and referred to in letter f) of Article 8.

The third payment for the fee relating to the Academic Year 2022-2023 equal to Euro 7,000.00 (seven thousand/00) must be paid by 31 January 2023. The publication of all relevant notices on the UniCamillus website is an official communication to the interested parties. Any personal communications that may be sent to the email addresses entered into the system by the candidates during the registration phase for the test will have the sole purpose of facilitating them in following the competition process, but will in no way replace the notices published on the website of the University which is the only official communication tool of the University. It therefore remains the responsibility of the candidate to verify his / her position by taking action in the manner and within the terms provided for in order to proceed with enrolment.

Italian and foreign students who have obtained their high school qualifications abroad must deliver to the Registrar's Office by 4th August 2022, under penalty of exclusion, an official translation in Italian (legalised if necessary) of the qualifications, accompanied by a Declaration of Value issued by the Italian Embassy or Italian General Consulate competent for the territory in the country where the qualification was obtained.

<u>Candidates not complying with the deadlines indicated above will be considered renouncing candidates and will lose the right to enroll. In this case, any costs already incurred, even during preenrolment, will in no case be reimbursed by the University.</u>

Candidates enrolled according to the aforementioned procedure, who have not correctly answered at least six out of ten questions respectively on Chemistry, Biology and Physics of the admission test, are admitted with Additional Educational Requirements, limited to that subject, and are required to attend a specific training course aimed at filling the education requirement identified, before taking the reference exam required by the Plan of Studies, and in any case within the first year of the study course. The fulfilment of the Additional Education Requirements will be verified by the professors holding the courses.

In the event that enrolment has been completed remotely or outside the University spaces, the student, within the term of 14 (fourteen) days, starting from the date of signing the Student Contract (in case of failure to indicate of the date on the Student Contract, the time will be calculated starting from the date in which payments were made), can exercise the right of reconsideration by clearly communicating to UniCamillus the will to reconsider their enrolment, by registered letter with return receipt. In case of exercise of the right to reconsider, UniCamillus will proceed to reimburse the student for the costs incurred for enrolment within the following 14 (fourteen) days -



withholding for secretarial and enrolment services an amount equal to 5% of the amount paid - using the same means of payment used by the User for the payment, unless a different means of paymen is expressly indicated.

Exercising the right to reconsider is equivalent to submitting a study waiver request as referred to in Article 13 of this Call.

The University does not reimburse payments made, except in the mandatory cases expressly governed by this Call and by the attached Student Contract.

Article 9 – Slots recovery

At the end of the online enrolment procedure of those entitled, a notice will be published on the University website indicating the number of slots still available, which may be covered through the slots recovery procedure, indicated below:

- publication on <u>www.unicamillus.org</u> of the number of slots available due to non-enrolment or study waivers (reopening of the ranking);
- those admitted for "scrolling" of the ranking must proceed with the enrolment according to what is provided for in this article by 5 PM on the second working day following the reopening of the ranking;
- the "scrolling" procedure will be repeated until the available slots are filled.

The publication of all notices about the scrolling of the rankings on the UniCamillus website is an official communication to the interested parties. Any personal communications that may be sent to the email addresses entered into the system by the candidates during the registration phase for the test will have the sole purpose of facilitating them in following the competition process, but will in no way replace the notices published on the website of the University which is the only official communication tool of the University. It therefore remains the responsibility of the candidate to verify his / her position by taking action in the manner and within the terms provided for in order to proceed with enrolment.

Suitable candidates are required to proceed with the enrolment providing the documents provided for in Article 8 of this Call, except for what is indicated in letter f) as the candidate is required to present receipt certifying the payment of the amount of Euro 14,000.00 (fourteen thousand/00) equal to the sum of the expenses referred to in letter c) of Art. 7 and referred to in letter f) of Article 8. The third payment for the fee relating to the Academic Year 2022-2023 equal to Euro 7,000.00 (seven thousand/00) must be paid by 31 January 2023.

Candidates not complying with the deadlines indicated above will be considered renouncing candidates and will lose the right to pre-enroll and will not be entitled to the refundment of payments made, except in the cases expressly governed by this Call and in the attached Student Contract.



Art. 10 – Enrolment extraordinary session (if any)

Successful candidates within 1 PM of the fifth working day following the date of publication of the results must proceed with online enrolment by also submitting the following documentation:

- Enrolment application (available online) addressed to the Rector, and acceptance of the UniCamillus Code of Ethics;
- Contract with the Student signed for acceptance (by the candidate or, if a minor, by a person who legally exercises parental authority);
- Digital photograph (to be uploaded);
- Photocopy of a valid identity document and photocopy of the fiscal code (foreigners legally residing in Italy must submit a valid residence permit);
- Certification or authenticated copy of the High School Diploma or, provisionally, selfcertification, pursuant to Presidential Decree 445/2000 regarding the possession of a high school diploma;
- Proof of payment of the amount of Euro 14,000.00 (fourteen thousand/00) equal to the sum of the expenses referred to in letter c) of Art. 7 and referred to in letter f) of Art. 8;
- Undersigned Privacy policy (available online);
- Revenue stamp of Euro 16,00;
- (Potential) study waiver documents (if enrolled in other university);
- Proof of payment of the Regional Tax (to be paid directly to the Regione Lazio);

Italian and foreign students who have obtained their high school qualifications abroad must deliver to the Registrar's Office by the beginning of the Academic Year 2022/2023, under penalty of exclusion, an official translation in Italian (legalised if necessary) of the qualifications, accompanied by a Declaration of Value issued by the Italian Embassy or Italian General Consulate competent for the territory in the country where the qualification was produced.

Candidates not complying with the deadlines indicated above will be considered renouncing candidates and will lose the right to enrol.

Any vacant slots will be managed according to the following scrolling procedure:

- Publication on <u>www.unicamillus.org</u> of the number of slots available due to missed registrations or study waiver (reopening of the ranking);
- those admitted for "scrolling" of the ranking must proceed with what provided for in this article by 5 PM of the second working day following the reopening of the ranking;
- the "scrolling" procedure will be repeated until the available slots are filled.

Candidates enrolled according to the aforementioned procedure, who have not correctly answered at least 6 out of 10 questions respectively on Chemistry, Biology and Physics of the admission test, are admitted with Additional Educational Requirements, limited to that subject, and are required to



attend a specific training course aimed at filling the education requirement identified, before taking the reference exam required by the Plan of Studies, and in any case within the first year of study course. The fulfilment of the Additional Education Requirements will be verified by the professors holding the courses.

Article 11 - Mandatory vaccinations

Upon enrolment, the successful student states his/her commitment to be screened, within 30 days from the enrolment:

- for tuberculin vaccination *(prova tubercolina)* performed according to the Mantoux technique, according to the guidelines on the Prevention of tuberculosis (provision 17.12.1998 of the State-Regions Conference) and by the D.P.R. 7.11.2001 no. 465, regulating tuberculosis vaccination;
- for viral hepatitis B, pursuant to Law no. 165 of 27 May 1991.

The student also declares his/her commitment to undergo any other available vaccination, which might be deemed appropriate by the University for the safety of the students themselves and of all those they can come into contact with, due to the academic activities they take part in.

The declaration model will be downloadable directly from the institutional portal of the University.

Article 12 - Requirements for maintaining the scholarship

Students who are awarded the scholarship referred to in Article 4.2 of this Call will be able to maintain the benefit in the same amount in the years following the first, within the legal duration of the course of study, if they, by September 30th of each year:

a) have acquired a number of credits at least equal to those shown in the following table:

b) obtained an average of marks in the exams referring to the overall educational credits achieved equal to at least 27/30.

To maintain the scholarship it will be necessary to have both of the above requirements.



Article 13 – Procedures for waiver, transfer and abandonment of studies

Students who wish to waive, will have to submit their study waiver request by using the University's student portal (Gomp) with their credentials, by going to the section: "career> applications> study waiver application".

Except in the case of exercising the right to reconsider the enrolment, which is equivalent to submitting an application for study waiver, in the event of waiver or transfer, the amounts already paid up to the time of submission of the relative application will not be reimbursed under any circumstances by the University, therefore, not even in the event of non-use of the Seminars made available to the student by the University.

The authorization (*nulla osta*) for outgoing transfer and the release of the relative documentation can only be granted to students in good standing, on the date of submission of the application, with the payment of academic contributions, taxes and stamps.

The student who waives from his / her studies or abandons them after the start of lessons is in any case required to pay in full the fees and contributions provided for by the Tuition Fees Regulations for the Academic Year in which he is enrolled. The Regulations are easily available on the UniCamillus University website at the link https://www.unicamillus.org/it/regolamenti/.

Article 14 - Remarks

The University reserves the right, in any stage of the enrolment procedure, to ascertain the truthfulness of the declarations made by the candidate, in accordance with current legislation. The candidate must therefore provide all the necessary elements to allow for the appropriate checks. In the event that the documentation submitted by the candidate contains false declarations, without prejudice to the penalties provided for by the penal code and by the special laws on the matter and the declarer's exposure to the action for damages by the other parties, the enrolment will be cancelled, any benefits granted will be recovered and the tuition fees paid will be retained (and they will not be reimbursed in any case).

The publication on the University website of the final ranking of the candidates who have taken the test and of any reordering is an official notification for all purposes of law towards the interested parties.

The University reserves the right to change dates, times, testing location and publication dates of results in addition to the location of the internships both in the region and outside the region and methods of providing courses, if it is deemed necessary for organizational reasons and/or for reasons of health safety, by publishing notices on the UniCamillus website which is the only official communication tool of the University.

In case of deferment, as long as it is decided prior to the deadline for the application to the admission test, the University reserves the right to postpone the deadlines for the submission of the



applications and, where deemed useful, accordingly modify the other dates provided for by this Call, by publishing the notice on the UniCamillus website which is the only official communication tool of the University.

The participation in the call for application implies the full and unquestionable acceptance of the provisions contained therein, included the provisions contained in the Student Contract attached to this Call and that constitute an integral part of it. For juridical and interpretative purposes the Call approved with Rector's Decree no. 5 of 10th December 2021, filed and available at the Didactic Office and drawn up in Italian language, and available upon request in certified copy, shall exclusively prevail.

For any matter not provided for in this call for application please refer to the Statute, the Didactic Regulations of the Degree Course and the Tuition Fees Regulations 2022/2023 of the University, which can be consulted easily on its website at the link https://www.unicamillus.org/it/regolamenti/.

Article 15 – Supervisory Committee for the regularity of the competition

With a specific decision, a Committee will be appointed to ensure the regular and proper performance of the operative procedures of the competition.

Cellular structures and their specific functions.

The cellular cycle and the cellular reproduction: mitosis and meiosis – chromosome set and chromosome maps.

Bioenergetic.

Cellular energetic value: the ATP.

Oxidation – reduction reactions of living organisms.

The energetic processes: photosynthesis, glycolysis, aerobic respiration and fermentation.

Reproduction and hereditariness.

Life-cycles. Sexual and asexual reproduction.

The periodic system of the elements: groups and periods, transition elements. Periodic properties of the elements: atomic radius, ionization potential, electronic affinity, metallic character. Relations between the electronic structure, position in the periodic system and elements property.

Oxidation and reduction: oxidation number, concepts of oxidant and reducing agents. Balance of simple reactions.

Acids and bases: acid and base concept. Acidity, neutrality and basicity of the water-based solutions. The pH. Hydrolysis. Buffer solutions.

Basics of organic chemistry: bonds between carbon atoms, rough and structure formulas, concept of isomerism. Aliphatic, alicyclic and aromatic hydrocarbons. Functional groups: alcohols, ethers, amines, aldehydes, ketones, carboxylic acids, esters, amides. Basics of nomenclature.

Physics

The measures: direct and indirect measures, fundamental and derivate quantities, physical dimensions of the quantities, knowledge of the decimal metric system and of the Unit Measure System CGS, Technical (or Practical) (ST) and International (SI), units of measurement (names and relations between fundamentals and derivate units) multiples and submultiples (names and values).

Kinematics: kinematic quantities, various motions with particular regard to the uniform rectilinear motion uniformly accelerated, uniform circular motion, harmonic motion (for all motions: definitions and relations between connected kinematic amounts).

Dynamics: vector and vector operations. Forces, moments of forces compared to a point. Moment to a torque of forces. Vectoral composition of the forces. Definition of mass and weight. Gravity acceleration. Density and specific weight. Universal gravitation law, 1st, 2nd e 3rd principles of dynamics. Work, kinetic energy, potential energy. Energetic conservation principles. Impulse and quantity motion. Conservation principle of the motion quantity.

Fluid mechanics: pression and its measurement units (not only in the SI system). Archimede principles. Pascal principles. Stevino laws.

Terminology, thermodynamics: thermometry and calorimetry, specific heat, thermic capacity. Mechanisms of heat propagation. Change of status and latent heat. Ideal gas laws. First and second principle of thermodynamics.

Electrostatics and electrodynamics: Coulomb laws. Field and electrical potential. Dielectric constant. Capacitors. Capacitors in series and parallel. Direct current. Ohm laws. Kirchhoff principles. Electrical resistance and resistivity, resistance in series and parallel. Work, Power, Joule effects. Generators. Electromagnetic induction and alternating currents. Electric current effects (thermic, chemical, magnetic).



Mathematics

Numerical sets and algebra. Natural, whole, rational, real numbers. Order and comparison; order of magnitude and scientific notification. Operations and their properties. Proportions and percentages. Power with external exponent, rational and their properties. Radicals and their proprieties. Logarithms (on the bases 10 and on the bases e) and their properties. Essentials of combinatorics. Algebraic expressions, polynomials. Special products, Nth power of a binomial, polynomials factor dissolution. Algebraical fraction. Equations and algebraical inequalities first and second degree. Equations system.

Functions: basic notions about functions and their graphical representations (domain, codomain, sign, maximums and minimal, growth and decreasing, etc.). Elementary functions: whole and fractional algebraic, exponential, logarithmic, goniometric. Multiple functions and inverse functions. Equations and goniometric inequalities.

Geometry: polygons and their properties. Circumference and circle. Measurements of lengths, surfaces and volumes. Isometries, similitudes and equivalences in the plan. Geometric locus. Measure of the angles in degrees e radians. Sine, cosine, the tangent of an angle and their special products. Goniometric formulas. Resolution of the triangles. Cartesian reference system in the plane. Distance of two points and average point of a segment. Equation of the line. Parallelism and perpendicularity conditions. Distance of a point from a line. Equation of the circumference, of the parabola, of the hyperbola, of the ellipse and their representation in the Cartesian plane. Pythagorean theorem. Euclid theorems (first and second).

Probability and statistics: distributions of the frequencies according to the type of character and main graphic representations. Concept of random experiment and event. Probability and frequency.

Humanistic culture and specific humanitarian mission of the University

The specific humanitarian mission of the University: important issues linked to the shortage of health workers in many developing countries, diseases that are widespread in these countries, Bodies responsible for dealing with humanitarian problems, eminent figures who have made a contribution in these related fields and topics. The required knowledge of these topics is not a specialized one: a mere competence deriving from the reading of newspapers and other normal means of information that commonly give news on these topics will be sufficient. In other words, these questions will be aimed at bringing out the interest of the candidates in the aforementioned issues which, if such interest exists, will certainly have been the subject of personal reading and study, albeit of an informative and non-specialist nature. Similarly, questions of general knowledge may be envisaged, in order to out a high level of social and humanistic culture deemed necessary for the quality of the personality of the healthcare professional trained by UniCamillus.

Art. 2 Services

Art 1 Adhacian

The enrolment in the University for the Academic Year 2022/2023 and the regular payment of the amounts due are the conditions required for the student to benefit of the related rights and services of the University for that Academic Year.

More specifically, the University undertakes to grant for all students:

- classrooms and teaching staff;
- didactic materials also in audio-visual format;
- access to areas dedicated to study;
- secretarial and mentoring services;

Art. 3 Student's obligations

The Student undertakes to actively take part in the activities promoted by the University, participating in all training activities related to the Course of studies - in compliance with the current laws or laws enacted as a result of emergency situations (e.g. Covid-19) -, including those required to fill any educational debts following the admission test (Additional Education Requirements, OFA, regulated by the Didactic Regulations of each Degree Course, and by the University Regulations) and the clinical practice provided for each course at the facilities indicated by the University.

The Student undertakes to fully respect the provisions of the Code of Ethics, the University Didactic Regulation, the Tuition Fees and Contributions Regulation, and of the other Regulations and Programme Regulations for the achievement of the Student's educational and professional objectives in the context of the curriculum chosen. The Student also declares to be fully aware of the contents of the aforementioned Regulations.

Art. 4 University contributions

University contribution is regulated by the Tuition Fees and Contributions Regulation for the A.Y. 2022/2023, published on the UniCamillus website and approved by the Organising Technical Committee of 9th November 2021.

The amounts requested from the Student as taxes or specific contributions do not represent a compensation for services, but an individual contribution to cover the cost of the services offered by the University.

The Student who is not in good standing with payments cannot be admitted to the exams, nor can he be enrolled in the next year of the course, nor can he obtain the authorization to transfer to another university.

Art. 5 Exams and compulsory attendance

The exams and the compulsory attendance are regulated as provided for by the University Regulations and by the Didactic Regulations of each degree course.

Art. 6 Duration of the Contract and Right of Withdrawal

The duration of this contract (which is concluded with its signing by the Student) is equal to the official



duration of the Degree Course or of the residual legal years in case of application/enrolment to years following the first (1st), due to a transfer and/or recognition of the knowledge and/or professional skills according to art. 5, comma 7 of the Decree 22/10/2004 n. 270.

In case the Student repeats a year or is out-of-course, the Contract will be tacitly and annually renewed for each additional Academic Year compared to the official duration of that Degree Course.

If this Contract is concluded remotely or outside University's grounds, within 14 (fourteen) days by the day of signing of this Contract (if the date is missing or is incorrect, the day of payment by the Student shall prevail), the Student may exercise their right reconsider and unilaterally terminate the Contract communicating clearly to UniCamillus their will to terminate, through a registered letter with notice of return (Raccomandata A/R).

If the Student exercises this right of reconsideration, UniCamillus will reimburse to the student the costs incurred for the enrolment within the following 14 days, withholding only the 5% of the amount paid by the Student, for secretarial and enrolment services born by the University, - using the same means of payment used by the User for the initial payment, unless expressly indicated a different means of payment. Exercising the right to reconsider is equivalent to submitting a study waiver request.

Art. 7 Transfer, Abandonment of Studies or Study Waiver

The Abandonment, the Transfer and/or the Study Waiver are regulated in terms and conditions as provided for by the Tuition Fees and Contributions Regulations of reference, by the Didactic Regulations of each study course, and by the Calls for Application for the Admission to which the student participated, which are all published on the UniCamillus website.
