THE RECTOR

- GIVEN** the Statute of the Saint Camillus International University of Health Sciences (UniCamillus);
- GIVEN** the Didactic Regulations of Saint Camillus International University of Health Sciences (UniCamillus)
- GIVEN** the Rector's Decree n. 107/2020 of November 5th 2020 and subsequent amendments and integrations "Call for application for the admission of EU and equiparated students to the six-year Degree Course in Medicine and Surgery in English at Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022"
- GIVEN** the Rector's Decree n 118 of December 4th and subsequent amendments and integrations "Call for application for the admission of non-EU students to the six-year Degree Course in Medicine and Surgery in English at Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022"
- GIVEN** the Ministerial Decree n. 740 of June 25th 2021 "Provisional definition of the available slots for the enrolment in the 6-year Degree Course in Medicine and Surgery (Italian language and English language) a.y. 2021/2022 that, pending the Agreement of the State-Regions Conference, has provisionally allocated the slots;
- GIVEN** the Agreement reached by the State-Regions conference on August 4th 2021 related to the available slots for the enrolment in the 6-year Degree Courses in Medicine and Surgery – a.y. 2021/2022;
- Considering** that upon completion of the enrolment procedures in the first year of the Degree Course in Medicine and Surgery in English of UniCamillus University in Roma, a.y. 2021/2022, as referred to in the Rector's Decree n. 26/2021 "Acknowledgement of the ranking of candidates participating in the Call for Application for the admission of EU and equiparated students to the 6-year Degree Course in Medicine and Surgery in English 2021/2022" and the Rector's Decree n. 20 of February 5th 2021 "*Università UniCamillus for the a.y. 2021/2022*" and following the above mentioned Ministerial Decree n. 740/2021, 18 slots have become available following the previous call;

- GIVEN** the Rector's Decree n. 130 of August 9th 2021 ss.mm "Call for application for the admission of EU and non-EU students to the 6-year Degree Course in Medicine and Surgery in English of the Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022", that has issued the public competition for the coverage of the 18 vacant slots and that has planned the related written test for October 2nd 2021;
- GIVEN** the Ministerial Decree n. 1071 of September 1st 2021 "Definition of the available slots for the enrolment in the 6-year Degree Courses in Medicine and Surgery (Italian language and English language) for the EU candidates and non-EU candidates residing in Italy and for non-EU candidates"
- Considering** that the Ministerial Decree n. 1071 of September 1st 2021 caused a reduction of the number of available slots allocated for the 6-year Degree Course in Medicine and Surgery in English - a.y. 2021/2022-, compared to those which the Ministry of University and Research originally assigned to UniCamillus with Decree n. 740 of June 25th 2021;
- Considering** that on September 7th 2021 UniCamillus appealed before TAR (Regional Administrative Court) Lazio, Rome office, seeking the annulment, subject to the adoption of appropriate precautionary measure, of the Ministerial Decree n. 1071 of September 1st 2021 in the part in which it reduced the number of available slots for the 6-year Degree Course in Medicine and Surgery in English - a.y. 2021/2022, already allocated with Decree n. 740 of June 25th 2021;
- Considering** that the TAR (Regional Administrative Court) Lazio, Rome office, planned the council chamber for the above mentioned proceedings for October 6th 2021
- Considering** that with the Rector's Decree n. 130 of August 9th 2021 "Call for application for the admission of EU and non-EU students to the 6-year Degree Course in Medicine and Surgery in English of Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022" the written test was planned for October 2nd 2021 for the public competition for the coverage of the 18 vacant slots
- Considering** that, however, awaiting the chamber council of October 6th 2021 and until the adoption of the related precautionary injunction, the above mentioned written test cannot be held;

DECREES

ARTICLE 1

The suspension of the D.R. 130 of 09/08/2021 “Call for application for the admission of EU and non-EU students to the six-year degree course in Medicine and Surgery in English of Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022”, for which UniCamillus issued a public call to cover 18 available seats from the previous call, whose written test was scheduled on October 2nd, 2021.

ARTICLE 2

to await the conduct of the Council Chamber of 06/10/2021 and to reserve, given the result of it, to schedule the written test of the public call to cover n. 18 available seats, issued with the D.R. 130 of 09/08/2021 and subsequent amendments and additions “Call for application for the admission of EU and non-EU students to the six-year degree course in Medicine and Surgery in English of Saint Camillus International University of Health Sciences (UniCamillus) for the academic year 2021/2022”

ARTICLE 3
