



**Rector's Decree no. 172 of April 29th, 2024**  
CALLING FOR ELECTION OF STUDENTS' REPRESENTATIVES OF  
UNICAMILLUS DEGREE COURSE IN NURSING COHORT 2021/2022

**THE RECTOR**

**GIVEN** the Statute of the University UniCamillus of Rome;

**GIVEN** the Didactic Regulations of the University;

**GIVEN** the Code of Ethics and the 231 Organization, Management and Control Model of the UniCamillus University;

**GIVEN** the electoral Regulation for the election of students' Representatives of UniCamillus degree courses and subsequent amendments and additions;

**GIVEN** Article 13 of the Regulation for the election of the student representatives in the degree courses of Unicamillus;

**GIVEN** the Minutes Prot. No. 00001.90/2024 of the meeting between the Head of School and the Programme Director of the BSc Nursing, held on 10.04.2024;

**GIVEN** that the above-mentioned Minutes indicate the need to increase the number of representatives for the BSc Nursing programme and that there are no further candidates in a useful position on the list;

**GIVEN** that it is necessary to call elections to identify additional student representatives for the UniCamillus BSc Nursing, third year (Cohort 2021/2022);

**HEREBY DECREES**

**Art. 1 – Elections calling**

1. We are calling the elections for one representative of students enrolled in the degree course of Nursing at UniCamillus - Cohort 2021/2022.

**Art. 2 Submission of applications**

1. Applications must be submitted from 00.01 (GMT+1) on May 6th, 2024 until 23.59 (GMT+1) on May 10th, 2024.

2. The submission of applications will take place in accordance with the procedures outlined in art. 6 of the Electoral Regulation.

**Art. 3 – Voting procedure**

1. Voting operations will take place in accordance with the procedures outlined in art. 7 of the Electoral Regulation.

**Art. 4 – Election day**

1. The voting system will be available in the days and at the times as follows:

Voting operations start at 00:01 (GMT+1) on May 15th, 2024.

Voting operations end at 23:59 (GMT+1) on May 15th, 2024.

2. After the deadline, the online system will be shut down and it will not let the completion of the voting procedure to whom may be connected.

**Art. 5 Electronical scrutiny operations**

1. The Electoral Commission, once ascertained the number of voters and the regularity of voting operations, will start the scrutiny operations on May 16th, 2024 at 10:00 (GMT+1) a.m.

**Art. 6 Reference to other provisions**

In those matters not regularized by this decree of calling, please refer to the Electoral Regulation for the election of Representatives of students enrolled in Degree courses at UniCamillus.
