**ERASMUS+ CALL FOR APPLICATIONS  
FOR THE SELECTION OF STUDENTS MOBILITY FOR STUDY (SMS) PURPOSES  
FOR THE FIRST SEMESTER OF THE ACADEMIC YEAR 2024/2025**

**Approved by Rector's Decree no. 93 of 12<sup>th</sup> March 2024**

The Erasmus+ programme for study purposes allows university students to increase training opportunities, aimed at acquiring the skills needed to facilitate the transition to the world of work.

**Article 1 - Purpose**

For the first semester of the academic year 2024/2025, as part of Key Action 1 of the Erasmus+ Programme, UniCamillus University announces a selection procedure for the awarding of international mobility grants, to carry out mobility activities abroad during the first semester (academic year 2024/2025), at European partner universities with which UniCamillus has signed bilateral agreements.

**Article 2 - Admission requirements**

UniCamillus students who meet the following requirements can participate in the selection:

- being up-to-date with the payment of tuition fees;
- having a weighted average of marks obtained by the deadline of the call of 25/30 or higher;
- having obtained - on the date of submission of the application - a minimum number of ECTS equal to:
  - 20 ECTS for students enrolled in the second year of programme in the academic year 2023/24;
  - 40 ECTS for students enrolled in the third year of programme in the academic year 2023/24;
  - 60 ECTS for students enrolled in the fourth year of programme in the academic year 2023/24;
  - 80 ECTS for students enrolled in the fifth year of programme in the academic year 2023/24.
- being in possession of the certification of the appropriate language skills based on the chosen destination(s);
- being regularly enrolled in the academic year 2023/24 in one of the following degree courses and years of study:

Students who apply to participate in the Erasmus+ Call for applications must take into account that the internship can be carried out at the same time as the Erasmus+ experience or at any host university, but not for the entire maximum duration of the stay (6 months). The curricular practice activity, carried out during the mobility period, may be recognized as equivalent to the curricular internship up to a maximum limit of 150/180 hours per semester.

For students who have been awarded the Erasmus+ grant, the language proficiency - on the basis of the assigned location - must be attested by means of an official external certification to be attached to the application form:

- English: IELTS, TOEFL, Cambridge (FCE, CAE, CPE)
- Spanish: DELE
- French: DELF, DALF, ESABAC
- German: Goethe-Zertifikat, Zertifikat ÖSD, ZD - Zertifikat Deutsch

Should students not have the language certificate required by the destination university, location at the time of submission of their Erasmus+ mobility application, they may sign a self-certification through which they undertake to obtain this certification by **31 July 2024**.

Students holding a high school diploma obtained abroad, will be assigned the C1 language level upon presentation of the regular documentation of the exams sat and their language level (self-declarations are not accepted), will be assigned the C1 language level.

### Article 3 - Positions and Locations

The list of available locations and positions available for each location and for each programme is attached to this Call for applications (ANNEX A) and can also be consulted on the website on page [www.unicamillus.org/it/scambi-internazionali/](http://www.unicamillus.org/it/scambi-internazionali/). This list may be subject to changes as a result of new agreements signed or changes requested by partner universities or by the European/national bodies that regulate the programme (please monitor the constantly updated page [www.unicamillus.org/it/scambi-internazionali/](http://www.unicamillus.org/it/scambi-internazionali/)).

Successful students are reminded that it is their responsibility to contact the host universities, but **only after** the Erasmus Office has sent the names of the successful candidates to their respective universities and that they have confirmed their acceptance.

It is recommended that students who have been awarded the grant according to the Call for applications pay attention to the indications that will be provided by the coordinators of the partner institutions and to monitor the academic calendars of the host universities.

#### **Article 4 - Application submission**

The application for participation in the Erasmus+ Call, complete with the required documentation, must be made by accessing with your credentials the GOMP student portal at the URL:

The application must be completed online **no later than March 25, 2024, at 11:59 p.m.**, by connecting to the GOMP portal in the section:

**HOME—> International Mobility—> Education—> Mobility Call**

Once the application has been completed, the system will provide a confirmation of completion and it will be possible to print a summary of the application and/or download a reminder; A copy of the completed application will be sent to your email inbox.

Interested students can submit **a single application** in which it is possible to list up to a maximum of three locations, in order of preference, chosen from those available, indicated in ANNEX A as possibly updated on the website on page [www.unicamillus.org/it/scambi-internazionali/](https://www.unicamillus.org/it/scambi-internazionali/). For each location there is a certain number of seats as well as restrictions relating to the academic year of the course, the course of study and the language level required by the host university.

Candidates will be excluded if their applications:

- are incomplete or incorrect in their essential parts;
- are not drawn up in the form provided;
- contain untruthful statements or documentation;
- are not in compliance with the payment of tuition fees.

#### **Article 5 - Criteria and assessment of applications**

The applications received, following the procedures and deadlines set out in this Call for applications, will be examined by a special Commission that will make the ranking based on criteria of academic merit (number of ECTS obtained on the date indicated and weighted average of marks) as detailed below:

### A. Number of ECTS

For the purposes of the score awarded, the ratio of career ECTS acquired within the deadline of the Call will be taken into consideration, compared to the total number of ECTS that can be obtained<sup>(1)</sup>, i.e. ECTS obtained by the deadline of the Call ÷ ECTS that can be obtained based on the academic year of enrolment.

When filling in the application, all the ECTS valid for the graduation obtained and recorded in the career and displayed on the GOMP portal within the deadline of the Call will be automatically considered.

An additional score will be attributed to the above ratio as shown in the table below:

**Table – Score assigned according to earned ECTS**

### B. Weighted Average

For the purposes of the score awarded, the precise value of the weighted average will be taken into account, which must be at least equal to or greater than 25/30.

<sup>(1)</sup> The maximum number of ECTS that can be obtained is calculated by multiplying 60 by the year of enrolment at the time of the deadline of the Call.

## Article 6 - Rankings

The rankings will be published by 28/03/2024 on the website [www.unicamillus.org](http://www.unicamillus.org).

In the event of a tied score, the applicant their first experience of international mobility during their course of study prevails, in the event of a further tie, the student enrolled in subsequent years of study prevails; and finally, the youngest student shall prevail.

Please note that in six-year degree programmes such as Medicine and Surgery, students can take advantage of a mobility period of up to 24 months; For three-year degree programmes, the maximum duration allowed is 12 months.

Should the number of available positions increase, as a result of withdrawn student or new agreements signed with other universities, the University reserves the right to draw from the same ranking list or to make a new notice.

## Article 7 - Acceptance of the Mobility Grant

By **03/04/2024** at 11:59 p.m., the student who has been awarded the Erasmus+ grant for student mobility for study purposes for the academic year 2024/2025 is required, under penalty of exclusion, to formally accept the Mobility grant by confirming **the location** through the **Acceptance of location** function in the international mobility section on the GOMP portal.

Following the acceptance of the location, the Erasmus Office will send the student's name to the host institution within the deadlines indicated by the latter.

### **PLEASE NOTE:**

The student's participation in the mobility scheme is, in any case, subject to admission by the host institution, which may require additional certifications/documents or reject the application.

## Article 8 - Applicant withdrawal or replacement within ranking list

The awarded student who intends to withdraw must submit their **Withdrawal from Mobility** request through the GOMP portal in the Acceptance/Withdrawal section, and at the same time send confirmation of the withdrawal request by email from their institutional mailbox to the email address [outgoingstudents@unicamillus.org](mailto:outgoingstudents@unicamillus.org)

The University reserves the right to assign the remaining available positions by drawing from the same ranking list or by making a new notice.

**Under no circumstances will it be possible to exchange the location obtained with the one chosen by another student.**

## Article 9 - Forfeiture

The student awarded the Erasmus+ grant forfeits it if one of the following cases occurs:

- loss of student status;
- withdrawal from the Erasmus+ grant;
- any cause, duly justified, which makes the student not eligible to continue their

stay abroad.

## **Article 10 - Fulfilments before, during and after mobility**

### **10.1. Before mobility**

All students admitted to the mobility programme will be required to attend the Erasmus meetings during which they will receive the necessary instructions and information to prepare for departure and to check the programmes of the host universities.

Subsequently, all admitted students are required to contact the Programme Director of UniCamillus for the submission, assessment and consequent acceptance of the Learning Agreement.

**Learning Agreement or LA** - All students must fill in the official study plan, the so-called Learning Agreement, which defines the teaching activity to be carried out at the host university and guarantees the recognition of the ECTS obtained by passing the exams.

To fill in the application, it is necessary to access the **OLA** (Online Learning Agreement) portal at the URL <https://learning-agreement.eu/> and create your own Mobility profile, which will also remain valid for future mobility opportunities.

The Learning Agreement duly filled in and signed by the student must be validated by acceptance by the Programme Director by means of a stamp and signature. Subsequently, it must also be approved by the contact person in charge at the host university: this acceptance is an essential obligation.

**Financial Mobility Agreement** – After the completion of the Learning Agreement, the student must make an appointment with the Erasmus Office for the compilation and signing of the Financial Mobility Agreement (containing personal data and bank details where to receive the mobility grant).

**Online Language Support (OLS)** - The Erasmus+ Programme requires the successful candidate to take a compulsory online language proficiency assessment test before and after the mobility, with the exception of mobilities to Switzerland. Participation in language assessment tests is an integral part of the Erasmus+ Programme.

To proceed with this **OLS (Online Language Support)** obligation the Erasmus Office will send a special invitation to the candidate's personal email in which they must participate.

**Students' duties.** It is necessary for the student to independently carry out the registration procedures required by the host university according to the methods and deadlines set by it.

Students are responsible for their accommodation for the whole duration of their study programme abroad. They may contact the host university to check for availability of

student residences and/or accommodation services.

**Non-EU students' duties.** Non-EU students must independently enquire about and arrange for healthcare assistance in the host country and how to enter the host country by contacting the respective diplomatic representations (Embassies and Consulates) in good time.

**Health insurance.** The accident and third-party liability insurance, which students benefit from with enrolment in UniCamillus, is extended in the same way for the entire period spent abroad at the host university.

Before departure, students are invited to enquire about extension of their National Health Assistance insurance in the host country by contacting their local Health Authority (Azienda Socio Sanitaria Territoriale - A.S.T.). Primary healthcare assistance and direct access to national health services in EU Member States are generally guaranteed by the European Health Insurance Card (EHIC). It will be students' responsibility to obtain this card if they do not have it or if it has expired or is lost.

### 10.2. During mobility

In order to avoid delays in the awarding of the grant, as soon as the student arrives at their destination, they must request that their **Certificate of Arrival** be filled in and signed by the relevant offices in the host university and send it to the e-mail address [outgoingstudents@unicamillus.org](mailto:outgoingstudents@unicamillus.org). This form can be downloaded from the Erasmus+ forms section of the page <https://www.unicamillus.org/it/scambi-internazionali/>.

If necessary, the student may propose changes to the contents of the initial Learning Agreement that must be promptly agreed upon and submitted for signature (within a maximum period of 10 days from arrival) to the UniCamillus Programme Director and the host University.

At the end of the study programme abroad, before returning to their home institution, students must request from the host university a certificate of the academic activities carried out (**T. O. R. or Transcript of Records**) and the **Certificate of Attendance** which must be sent to the address [outgoingstudents@unicamillus.org](mailto:outgoingstudents@unicamillus.org). ### 10.3. After Mobility

In order to receive the balance of the financial contribution, the student, at the end of the international mobility, must:

1. **Narrative report (EU survey)** - the student, at the end of the mobility period, will have to fill in the narrative report (EU SURVEY). The Erasmus Office will forward the link to the students who have been awarded the Erasmus+ grant once the

mobility period is over.

2. **Online Language Support post Erasmus** - the student, at the end of the mobility period, will have to take a second **OLS (Online Language Support)** online test to assess their progress.

## Article 14 – Compliance with the provisions of UniCamillus "Tuition and Fees Regulations"

Successful students will be duly enrolled at UniCamillus even during their stay abroad and are required to comply with the deadlines relating to tuition fees, study plans, graduation applications, etc.

Successful students are exempt from paying the partner university's tuition fees.

## Article 15 - Contributions

Mobility contributions are awarded exclusively for academic activities carried out abroad. The duration of the mobility must be **at least 2 months** (60 days) and up to a maximum duration of 24 consecutive months for the MSc in Medicine and Surgery and 12 months for BSc programmes, and must be carried out in the semester(s) of the Call.

Erasmus+ Mobility Grants are awarded in accordance with the ranking list within the limits of available funds. The amounts of Erasmus+ Mobility Grants vary according to the host country and in relation to the cost of living:

The actual contribution is calculated on the basis of the mobility days actually spent abroad, as resulting from the Attendance Certificate issued by the host university.

The funds are allocated in two instalments:

- the first, equal to 70%, at the beginning of the mobility period;
- the second, equal to 30%, at the end of the mobility period and in any case following the fulfilment of all the above-mentioned obligations.

In the event of early termination of the study programme abroad, the amount of the grant is recalculated in proportion to the period actually spent abroad.

If the student decides to spend abroad a period shorter than the one budgeted in the Mobility Agreement (but in any case, longer than 2 months), they will have to return the part of the excess funds. Erasmus+ grant winners who spend less than 2 months (60 days) of effective mobility abroad will not be entitled to any Erasmus+ Project funds and will have to return the full amount received.

The Erasmus Programme 2021-27 provides for a **Green Travel** contribution which is identified with the following characteristics:

Sustainable means of transport: bicycle, bus, car-pooling and train.

Unit travel contributions for sustainable means of transport (eco-travel) are eligible if these means have been used for most of the outward and return journey.

On the other hand, for a "standard" journey (by means of air transport) there is a **unit contribution for distance range in kilometres**: the amount paid for the round trip between the place of departure and the place of destination. This amount is calculated per one-off kilometre distance range.

### **Article 16 - Disabled students and inclusive education**

In compliance with the provisions and foundation of the Erasmus+ Programme, and in order to allow wider participation in mobility programmes, the Erasmus+ National Agency (INDIRE) may offer upon request an additional financial contribution for disabled students and inclusive education.

It is a well-established practice for the home institution to coordinate with the host institution so that the latter takes the necessary measures to meet the particular needs of the person concerned provided that they have communicated their physical, mental or health conditions.

### **Article 17 - Personal data protection**

Pursuant to art. 13 of Regulation EU/2016/679 (hereinafter also "GDPR"), the processing of personal data provided by students to participate in this Call for applications or in any case acquired for this purpose by UniCamillus University, in its capacity as data controller (with registered office in Rome, Via di Sant'Alessandro 8 - 00131 Rome; Email: info@unicamillus.org; registered email: unicomillus@pec.it; Phone: + 39 06 40 06 40) is aimed exclusively at conducting the procedure in question and will be carried out, by the persons in charge of managing it and the members of the Commission for the preparation of the ranking, at the UniCamillus University, also through IT tools, according to the principles provided for by art. 5 of the GDPR and within the limits necessary for the pursuit of the purposes described above. The provision of such data is necessary to assess the requirements for participation and the possession of qualifications; failure to provide them may preclude such assessment. The data provided may be communicated to other public administrations for the purpose of verifying what has been declared.

The interested parties may exercise the rights referred to in art. 15 et seq. of Regulation EU/2016/679. The appropriate request is submitted by contacting the Data Protection Officer at UniCamillus University (Via di Sant'Alessandro 8 – 00131 Rome, Email: dpo@unicamillus.org). The interested parties, if the conditions are met, also have the right to lodge a complaint with the Italian Data Protection Authority (the "Garante") for the protection of personal data, as a supervisory authority, or to take legal action.

### **Article 18 - Warnings**

For legal and interpretation purposes, only the Call for applications approved by Rector's Decree, filed and available at the UniCamillus Teaching Services Office and drafted in Italian, is valid. A certified copy may be obtained.
