This program lasts for one academic year, during which students will acquire both theoretical knowledge and practical skills. The purpose of the master is to provide clinicians with necessary means for a correct diagnostic and operative approach to an ideal implant prosthetic rehabilitation. Students will be drawn into modern implantology from the diagnosis to the prosthetic rehabilitation and will have the chance to get in contact with the most modern surgical techniques and technologies. The official language of the Master will be English.

<p><b>Participation Fee</b></p>	<p>The participation fee is 9.000 € to be paid in 3 intervalls of the same :</p> <ul style="list-style-type: none"> <li>• Euro 3.000 → by 15/02/2022 (Together with the submission of the application for admission)</li> <li>• Euro 3.000 → by 15/05/2022</li> <li>• Euro 3.000 + Euro 50 DUTY STAMPS = tot €3050 → by 15/09/2022</li> </ul> <p>If the candidate does not make the payment within the time specified by UniCamillus he will lose the right to enroll / participate.</p> <p>Failure to pay the installments within the established terms will block the student’s didactic activities. Hence, this will result in a non-admission to the final exam and, thus, a failure to earn the degree.</p> <p>The student is required to pay the remaining installments even if an interruption of his didactic activities will occur.</p> <p>The student can exercise the right of withdrawal within 14 days from the payment date of the first installment, by sending, within the aforementioned deadlines, a registered email to the following address <a href="mailto:postlaurea.unicamillus@pec.it">postlaurea.unicamillus@pec.it</a>. In this case, the relative reimbursement will be made within 30 days from the student's communication. Moreover, 10% of the amount paid will be retained as a penalty.</p> <p>The Master will only be activated if a minimum number of participants is reached. In the event that the Master does not begin due to failure to reach the minimum number, the University will refund the entire amount paid without withholding anything as a penalty.</p>
